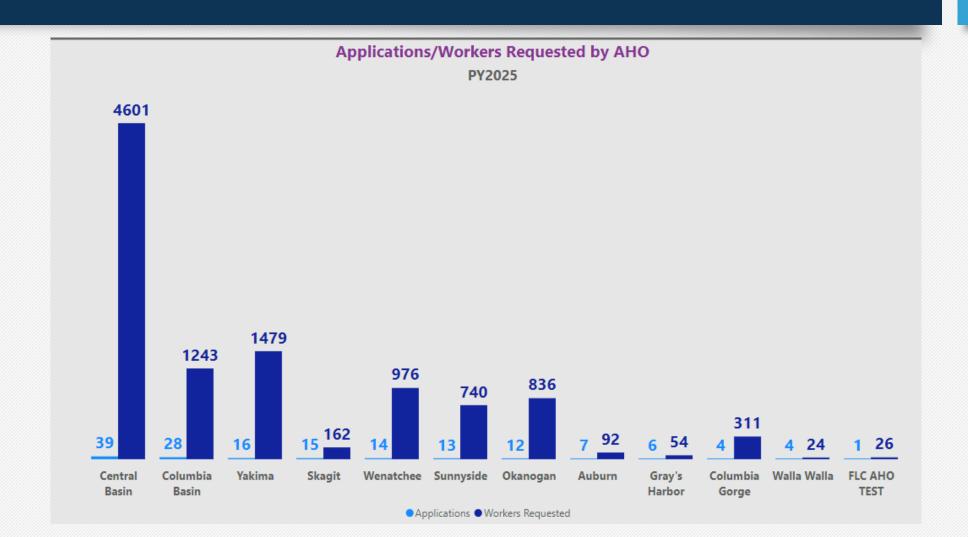

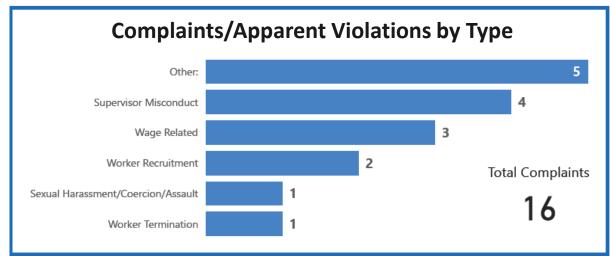

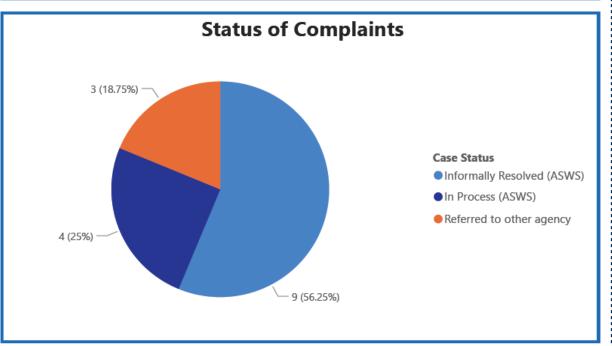

### Highlights of Outreach to Farmworkers



#### Manson & Orondo Area

### MSFW Staff assists farmworker find employment and housing

- MSFW from California returned to WA for seasonal employment, expecting to work at an orchard which had been pushed out.
- Without shelter, MSFW stayed in neighboring MSFW camp and was thrown out by employer due to trespassing.
- MSFW staff assisted customer in navigating bus system and led him to Monitor MSFW Camp where they networked with manager.
- Result: MSFW was hired for summer employment and found housing.

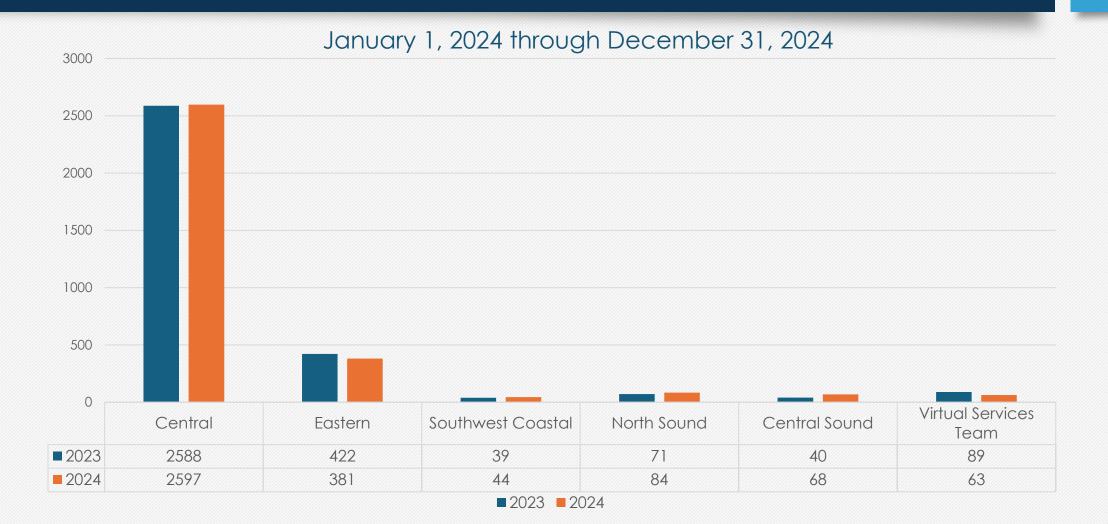
#### **Wenatchee Area**

#### Collaborative meeting with Ag. Employer

- Coordinated a meeting between local business services team, OIC of WA, and employer HR team.
- Offered tailored presentation on ESD's Shared Work program and potential trainings for workers and their families.
- Result: Employer has shown increased engagement and reached out to request information on CPR training and sexual harassment training.

# MSFWs Served by Region • Rolling 12 Months

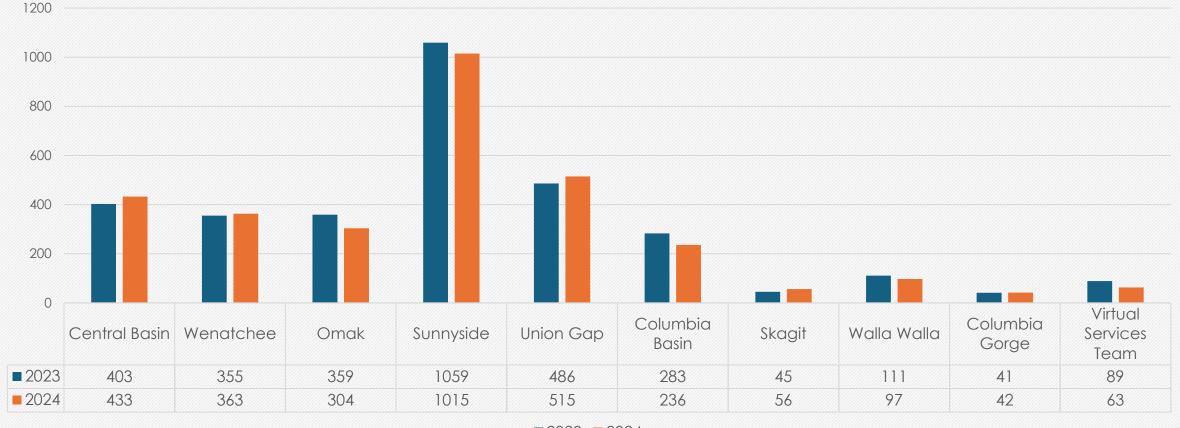




# MSFWs Served by Significant Office • Rolling 12 Months

- ESD requested funding to expand the program to improve service to domestic and H-2A farmworkers; centralize management of H-2A job orders and track referral outcomes consistently; and improve communication to farmworkers and employers. Request included a fund swap of the current program from ESD's state account (CPP) to General Fund State.
- Governor's budget funded position reclassifications for current staff, increased travel costs and one new position to create a central point of oversight of domestic farmworker recruitment, referral, and placement.
